WEAR A MASK – Masks are required in Oregon when you are inside any public space AND when you are outside in a place where you will pass multiple people or have to pass closely (so... while on a hiking trail or in a busy area of a park, while shopping on Division or Hawthorne...). As of this week, children 5 and older are also required to wear masks in these situations. This month the board heard a presentation from Vibrant Portland, a group organized around relocating Union Pacific from the Brooklyn and Albina Rail Yards. Southeast Uplift had previously contributed financially to help fund an engineering study to further this project. The Southeast

The organization adopted its first statement on Diversity, Equity, Inclusion, and Accessibility (DEIA), including guidelines for evaluating organizational policies and programs.

Finally, due to the budgetary impact of COVID-19, Portland / Civic Life will be unable to fund community small grants this year. The Southeast Uplift board voted to continue to support this program at a lower financial level by rebalancing its own budget.
